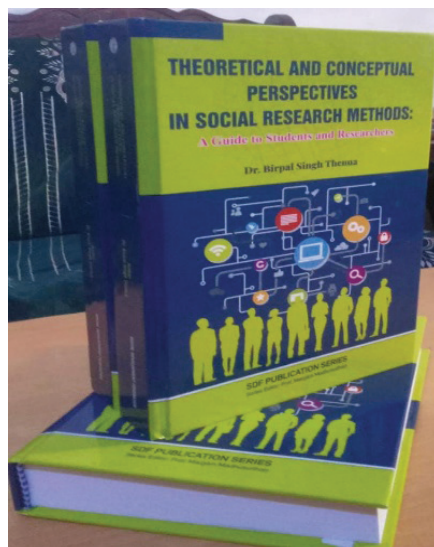

Chapter third focuses on survey research with systematic history of survey in India. Chapter four outlines the necessity of following systematic steps in social research, with reference to the approaches of Goode and Hatt, and P.V. Young. Chapter fifth had a clear description of variables, which are fundamental elements in designing and analysing research studies and chapter sixth addresses the ethical considerations, key principles, and the importance of ethics in conducting social.

research. Chapter seven explores research design which provides a blueprint for planning and executing research projects effectively and chapter eight explains the qualitative and quantitative research approaches in social research. Chapter nine focuses on the process of defining research problems, understanding theoretical frameworks, and addressing the challenges faced by researchers in this critical step. Chapter ten has a detailed description on hypotheses. This chapter also discusses the significance of hypotheses in guiding research inquiries. Chapter eleven distinguishes between primary and secondary data, their key features, sources, and the importance of studying both types in social research. Chapter twelve, thirteen, fourteen and fifteen explore observation, interview, questionnaire, and schedule as research tools. Chapter sixteen provides a historical background, definition, key characteristics, data

sources, and the methodology of conducting case studies. This chapter highlights the value of case studies in providing in-depth insights into specific phenomena. Chapter seventeen explains the need for sampling, its definition, key characteristics, several types, importance, and limitations. Sampling is crucial for ensuring that research findings are representative and generalizable. Chapter eighteen and nineteen discuss the importance of logical reasoning, inductive, deductive, and abductive methods in social research. There is a detailed explanation on quantitative aptitude, its key aspects, importance, drawbacks, and applications in social research, emphasizing the role of quantitative skills in analysing data. Chapter twenty and twenty-one cover statistical analysis, its key aspects, need, and methods such as editing, coding, classification, tabulation, inferential statistics, and descriptive analysis. There is an introduction of content analysis, its key features, theoretical foundations, methodological approaches, purpose, utility, advantages, and limitations in social research. Chapter twenty-two and twenty-three emphasize the need for writing research reports, provides tips, an outline for social science reports, and discusses various types of research reports and also explain the structure and format of synopses, dissertations, projects, and research papers, including examples and detailed guidelines for APA style reference
