In his article, Dr. Raj Kumar Gurung explores feminism on this site to make the readers aware of female identity and gender equality by teaching feminism in EFL classes because society is not free from the grip of male domination. Likewise, Mr. Raj Kumar Sharma focuses on how English literature assists to ameliorate English language in English language teaching (ELT) classes attempting to analyze how literature attunes students with various language skills in ELT classrooms. In addition, Dr. Shyam Lal Magarati displays how the Dalit people have been living in a society bearing harsh torture, trauma, and inhuman treatment analyzing the poem Paitala Pukar in English literature.

The editorial and reviewer team tried their best to cook them and served them to the targeted readers in this journal.
